CEDAR LAKE – CARP FISHING

CEDAR LAKE – SITE / FISHERY RULES

WHEN ARRIVING AT CLEARWATER LAKES FISHERY: -

PARK IN AN ORDERLY MANNER ADJACENT TO THE FISHERY DIP TANKS ON THE ENTRANCE ROAD

ON ARRIVAL ALL NETS - LANDING - WEIGHING - AND UN-HOOKING BEDS TO BE DIPPED

- LANDING NETS 1 x 36" 42" (NO SHARING)
- CARP CRADLE OR LARGE PADDED UN-HOOKED BED (NO SHARING)
- WEIGHING SLING NET (NO SHARING)

ALL THE ABOVE TO BE DIPPED ON ARRIVAL AT THE FISHERY AND THEN LEFT OUT TO DRY AT THE ALLOCATED FISHING PEG PRIOR TO USE ANY ANGLER FOUND NOT TO HAVE STRICTLY COMPLIED WITH THE ABOVE WILL BE REQUESTED TO IMMEDIETLY LEAVE THE FISHERY AND NOT RETURN

<u>DIPPING AND DISSINFECTING THE ABOVE EQUIPMENT IS TO PREVENT THE SPREAD OF KHV (Koi Herpes</u> Virus) AND OTHER DISCEASES INTO OUR FISHERY

PROCEED BY CAR TO YOUR ALLOCATED FISHING PEG AND PAYMENT WILL BE TAKEN BY MANAGEMENT AT THE FISHING PEG

MAJORITY OF THE FISHING PEGS CARS CAN BE PARKED DIRECTLY BEHIND OR ADJACENT TO THE FISHING PEGS (EXCLUDING PEGS 122-128)

WHEN ARRIVING AT YOUR ALLOCATED FISHING PEG

PARK IN AN ORDERLY MANNER EITHER DIRECTLY BEHIND, ADJACENT TO OR AS CLOSE AS POSSIBLE TO YOUR FISHING PEG

IMMEDIATELY - LAY YOUR NETS - LANDING - WEIGHING - CRADLE / UN-HOOKING BEDS - OUT TO DRY

IMPORTANT: PLEASE ENSURE BEFORE FISHING THAT YOU READ THE FISHERY NOTICE BOARD ADJACENT TO PEG NUMBERS 101,109,114,118

READ ALL THE: <u>FISHING / TACKLE KIT – FISHING RULES – BAIT RULES – SITE RULES</u> AS DISPLAYED ON THE FISHERY NOTICE BOARD TO ENSURE THAT YOU FULLY COMPLY WITH ALL THE RULES.

DURING DAY / CARP FISHING

DURING FISHING IF ANY SPECIMEN OF FISH LANDED SHOW ANY SIGNS OF STRESS, SEVERE DAMAGE OR DISEASE THEN THESE SHOULD BE PLACED IN THE (FLOATING FISH CAGE/NET PROVIDED) AND IMMEDIATELY REPORTED TO THE MANAGEMENT ON **07969738765**

END OF DAY / CARP FISHING

FISH ARE NOT UNDER ANY CIRCUMSTANCES TO BE REMOVED FROM THE FISHERY (THIS WILL BE DEEMED A CRIMINAL ACT OF THEFT SECURITY CHECKS WILL BE COMPLETED BY MANAGEMENT)

ALL RUBBISH OR WASTE MATERIALS SHOULD BE COLLECTED AT THE ALLOCATED FISHING PEG BY THE INDIVIDUAL ANGLER AND REMOVED FROM THE FISHERY (TAKEN TO YOUR HOME)

OTHER RULES

NO VISITORS ARE ALLOWED ON THE LAKES (DAY OR NIGHT) UNLESS AUTHORISED BY THE MANAGEMENT NO: FIRES – DOGS – BICYCLES – MUSIC – BBQ'S MUST BE OFF GROUND – <u>BRIGHT LIGHTS OR TILLEY LAMPS</u> NO EXCESSIVE ALCOHOL DRINKING OR DRUG USE IS PERMITTED ON OR WITHIN THE FISHERY

THESE ARE CONDENSED RULES AND ALL THE FISHERY RULES CAN BE READ ON THE COMPANY WEBSITE

WE RESERVE THE RIGHT TO STOP & INSPECT ALL PRIVATE TRANSPORT ENTERING & LEAVING THE FISHERY

ANGLERS NOT STRICTLY ADHERING TO THE FISHERY - SITE RULES - FISHING - BAIT RULES WILL BE REQUESTED TO IMMEDIATELY LEAVE THE FISHERY AND WILL NOT BE PERMITTED ENTRANCE TO THE FISHERY THEREAFTER.
